**Address Change.** Notice of change in address should be received by the Assistant Business Manager at least 40 days previous to month of Journal issue. Lost copies, owing to change of address, cannot be supplied unless adequate notice has been given.

**Missing Copies.** Claims for missing copies should be sent to the Assistant Business Manager within 90 days of publication date. Such claims will be allowed only if the Journal or the printing company is at fault.
