Address Change and Missing Copies. Notice of change in address should be received by the Executive Secretary in advance of change. Claims for missing copies should be received within 30 days (90 days foreign) of publication date to insure replacement copies at no charge.

Manuscripts. Address manuscripts and correspondence concerning them to the Editor-in-Chief R. A. Merkel, Department of Animal Sciences, Michigan State University, East Lansing, MI 48824. At least one of the authors of a manuscript must be a member of the Society. Publication of papers by nonmembers requires the approval of the Executive Committee. Authors are requested to designate in which section of the journal they prefer to have their manuscript considered for publication.

Reprints. Reprints of papers in the journal are obtainable only from the authors or their institutions. Authors of papers accepted for publication are required to make a minimal purchase of 100 reprints.
